PROCEDURAL ORDER

BY THE COMMISSION:

On March 30, 2001, the Arizona Corporation Commission ("Commission") issued Decision No. 63526 which granted a Certificate of Convenience and Necessity ("CC&N") to Telephone Company of Central Florida ("TCCF") authorizing it to provide resold interexchange telecommunications services in Arizona.

Pursuant to Decision No. 63526, TCCF was ordered to, among other things, file fair value rate base ("FVRB") information within 18 months of the date TCCF first provides service following certification.

On March 30, 2001, TCCF received certification in Decision No. 63526.

On August 30, 2001, TCCF requested it be granted an extension of time to file its FVRB information.

On October 19, 2001, Staff filed its response, recommending that TCCF file its FVRB information by September 30, 2002, which is 18 months from the date that TCCF began providing service following certification. Staff's recommendation is reasonable.


