RE: **COMPLIANCE TO DECISION NO. 63526** – REQUEST FOR EXTENSION OF TIME. (DOCKET NO. T-03441A-97-0533)

On August 30, 2001, Telephone Company of Central Florida ("TCCF") submitted correspondence requesting an extension of time to comply with one condition in the decision granting TCCF authority to provide resold interexchange telecommunications services (Decision No. 63526). TCCF's Certificate of Convenience and Necessity was conditioned on the Company filing fair value rate base information within 18 months of the date that TCCF first provides service. TCCF requests an extension to comply with this condition until twelve months from the date of certification.

Staff recommends that TCCF's request for an extension of time be granted because Staff's recommendation to the Administrative Law Judge was that TCCF file fair value rate base information within 18 months of the date that TCCF first provides service *following certification*. Therefore, Staff recommends that TCCF comply with the above condition within 18 months of March 30, 2001, the date that TCCF received certification. Staff recommends that TCCF file fair value rate base information by September 30, 2002.


