PROCEDURAL ORDER

10 **BY THE COMMISSION:**

11 On March 30, 2001, the Arizona Corporation Commission ("Commission") issued Decision
12 No. 63527 which granted authority to Telecents Communications, Inc. ("Telecents") to provide
13 competitive intrastate telecommunication services in Arizona.

14 Pursuant to Decision No. 63527, Telecents was ordered to, among other things, file
15 conforming tariffs within 30 days of the Order, and notify the Commission of the date it begins
16 providing service.

17 On May 24, 2001, Telecents filed its tariffs and the other required information and requested
18 it be granted an extension to comply with this requirement.

19 Staff has no objections to the request.

20 IT IS THEREFORE ORDERED that Telecents Communications, Inc.'s request for extension
21 is granted and its May 24, 2001 filing satisfies the filing requirements in Decision No. 63527.
