10 Arizona Water Company, an Arizona public service corporation, (the "Company")
11 pursuant to the provisions of A.R.S. §40-367, tenders for filing with the Commission its
12 proposed Tariff No. NS-275, Temporary Service.

13 By way of background, the Company's Tariff No. TC-243, *Terms and Conditions for the*
14 *Provision of Water Service*, contains certain general provisions concerning the Company's
15 provision of temporary service. (See Section II.E of Tariff TC-243)

16 In this filing, the Company is submitting a specific temporary service tariff that sets forth
17 particular terms and conditions for the provision of temporary service that will inform customers
18 of the specific customer requirements, and the Company's responsibilities concerning temporary
19 service. The Company believes, and therefore submits that this filing will improve a customer's
20 ability to obtain, and the Company's ability to provide temporary service.

21 The Company respectfully submits that proposed Tariff No. TS-275 is in the public
22 interest, and requests that proposed Tariff No. TS-275 be approved to become effective thirty
23 (30) days following the date of this filing.


24 Copies of proposed Tariff No. TS-275 will be open to public inspection at the Company's

TEMPORARY SERVICE

AVAILABILITY:

In all cities, towns and unincorporated areas in which the Company provides water service where facilities of adequate capacity and pressure are available for the provision of temporary service.

APPLICATION:

To water service which, in the opinion of the Company, is temporary in character, or is to be of limited duration. Also, water service which, in the opinion of the Company, is for operations of a speculative character, or which is to be provided to premises not improved with a structure of a permanent nature, is considered temporary service.

RATES, SERVICE CHARGES AND FEES:

Except as herein otherwise provided, the water rates, service charges and fees for temporary service shall be the same as those prescribed for permanent service established under the Company's tariffs applicable to water rates, service charges and fees.

ESTABLISHMENT OF TEMPORARY SERVICE:

If no undue hardship to its existing customers would result therefrom, the Company will establish temporary service provided the applicant for such service pays to the Company in advance of water service establishment, the estimated cost of installing and removing all facilities necessary to establish the temporary service; and

1. Deposits a sum of money equal to the estimated bill for water service where the duration of temporary service is to be less than one (1) month, or
2. Satisfies the Company's deposit requirements for permanent service where the duration of temporary service is to be more than one (1) month.

DISCONTINUANCE OF TEMPORARY SERVICE

1. If at any time during the term of the temporary service, the character of the customer's operations changes so that, in the opinion of the Company, the customer should be classified as permanent, the applicable sections of the Company's Terms and Conditions For The Provision Of Water Service will apply and govern the disposition of the customer's payment to the Company of the estimated cost of installing and removing the temporary service.
2. If at any time during the term of the temporary service, the character of the customer's operations causes hardship to the Company's permanent customers, the Company shall have the right to discontinue temporary service to the customer, but will provide a thirty (30) day advanced written notice to the customer of the Company's intent to discontinue service.

TERMS AND CONDITIONS:

Except as herein otherwise provided, water service under this tariff is subject to the Company's Tariff Schedule TC-243 and SC-252.
