**ALECA'S COMMENTS REGARDING
SEPTEMBER 3, 2004, PROCEDURAL
ORDER**

Pursuant to the September 3, 2004, Procedural Order in this docket, any request for a hearing must be filed no later than October 29, 2004. The Arizona Local Exchange Carriers Association ("ALECA") filed a motion to intervene on October 14, 2004, and the motion was granted by procedural order dated October 27, 2004. At this time, ALECA does not request a hearing. However, ALECA does intend to file comments on (i) the application of WWC License LLC, doing business as CellularOne, for Designation as an Eligible Telecommunications Carrier; and (ii) the Utilities Division Staff report that will be filed in this docket. ALECA's decision not to request a hearing in this docket is based in significant part on the fact that the Arizona Corporation Commission approved an order on a similar application filed by ALLTEL Communications, Inc. (Docket No. T-03887A-03-0316) on October 26, 2004. If ALLTEL seeks rehearing and appeal on its order, ALECA may subsequently request a hearing in this docket.
