BY THE COMMISSION:

On July 23, 2004, Arizona Electric Power Cooperative, Inc. ("AEPSCO") and Southwest Transmission Cooperative, Inc. ("SWTC") (collectively "Applicants") filed Applications for Rate Increases. By Procedural Order dated September 15, 2004, the matters were consolidated.

On October 19, 2004, Mohave Electric Cooperative, Inc. ("Mohave Electric") filed for Leave to Intervene in the above-captioned matters. AEPSCO is a partial requirements wholesale supplier of electricity, and SWTC is a partial requirements transmission supplier for Mohave Electric.

No party objected.

IT IS THEREFORE ORDERED that Mohave Electric's request to intervene is granted.


