**JOINDER IN MOTION
TO EXTEND HEARING**

On November 5, 2004 the staff of the Arizona Corporation Commission ("Staff") filed a Motion to Extend the Hearing Date (currently, November 30, 2004) in Docket No. W-04264A-04-0438. Staff also requested that the current procedural schedule be vacated, and a new one established, and that the consolidated Docket Nos. W-04264A-04-0438, W-04264A-04-0439 and W-01445A-04-0755 be put on the same timeline, to allow the respective applications therein to be reviewed and discussed concurrently.

Arizona Water Company ("AWC") joins in the Staff's Motion. AWC agrees with Staff that these applications present important public policy issues that require

1 additional time for discovery and consideration. Besides being unfair to Staff and the
2 affected utilities, having the Commission hear and consider these applications without
3 adequate preparation by all parties would deprive the Commission of its need for a
4 record that fully develops and presents the facts and issues necessary for the
5 Commission to render an informed decision in these consolidated proceedings.

6 Based upon the foregoing, AWC moves the Commission to grant Staff's Motion,
7 and to establish a new procedural and hearing schedule that is agreeable to all parties
8 to these matters.
