**PROCEDURAL ORDER**

10 **BY THE COMMISSION:**

11 On November 7, 2000, Encompass Communications, L.L.C. ("Applicant") filed with the  
12 Commission an application for a Certificate of Convenience and Necessity ("Certificate") to provide  
13 competitive resold interexchange telecommunications services, except local exchange services,  
14 within the State of Arizona.

15 In Decision No. 63539 (March 30, 2001), the Commission granted the Applicant a Certificate  
16 to provide resold interexchange telecommunications services, subject to the Applicant filing certain  
17 specified Fair Value Rate Base ("FVRB") information within 18 months of the date that it first  
18 provides service.

19 On July 8, 2002, the Applicant filed a letter in this docket indicating that it believed the FVRB  
20 information was to be taken from its Annual Report and, therefore, no separate FVRB information  
21 was filed. The Applicant attached a document to its letter indicating that its FVRB in Arizona is \$0.

22 On July 16, 2002, Staff filed a Memorandum stating that it does not oppose the Applicant's  
23 request for additional time to submit the FVRB information.

24 IT IS THEREFORE ORDERED that the request for additional time by Encompass  
25 Communications, L.L.C. to file its FVRB information is granted, and the July 8, 2002 filing satisfies  
26 the requirements of Decision No. 63539. Therefore, the Certificate of Encompass Communications,  
27 L.L.C. remains in full force and effect.

1 IT IS FURTHER ORDERED that the FVRB for Encompass Communications, L.L.C. is  
2 determined to be \$0 for purposes of its Application in this proceeding.


