STIPULATION BETWEEN PARTIES TO EXTEND SERVICE

Black Mountain Gas Company, a subsidiary of NSP Cave Creek Operations ("Black Mountain"), Staff of the Arizona Corporation Commission (the "Commission") and the Residential Consumer Utility Office ("RUCO") agree and stipulate that the following dates be moved and/or extended: (1) time to file rebuttal from December 20, 2000 to December 29, 2000; (2) time to file surrebuttal to January 18, 2001; (3) time to file rejoinder to January 25, 2001; and (4) date for hearing to be set from January 18, 2001 to January 28, 2001.

These extensions are not requested for purposes of delay, but to permit the parties adequate time to engage in settlement negotiations currently underway.




