**CLARIFICATIONS AS TO
MEMBERSHIP OF ARIZONA
COMPETITIVE POWER
ALLIANCE**

18 On September 27, 2004, Panda Gila River, LP ("Gila River") submitted its Statement of
19 Position in the above-captioned proceeding with regard to the proposed Settlement Agreement
20 filed therein on August 18, 2004.

21 The purpose of this Clarification of Membership of Arizona Competitive Power Alliance
22 ("Alliance") is to indicate that Gila River's filing does not reflect the views of the Alliance. The
23 views of the Alliance are set forth in the prepared testimony it submitted on September 27, 2004.
24 Those views are also expressed in the prepared testimony submitted by several of the Alliance's
25 members who participated as individual intervenors in the above-captioned proceeding. In each

1 instance, the testimony proffered by Alliance members supports the proposed Settlement
2 Agreement for the indicated reasons.

3 Gila River withdrew from membership in the Alliance on August 19, 2004. Its Statement
4 of Position speaks for no party other than itself.
