The Securities Division of the Arizona Corporation Commission ("Commission") files this Joint Motion to Continue the hearing currently scheduled to begin on October 12, 2004. The parties have agreed to continue this hearing until October 18, 2004.

On April 30, 2004, the Securities Division filed a Notice of Opportunity against HCH Enterprise, L.L.C. ("HCH"), Helen C. Hartze ("Hartze") and Mark Kesler ("Kesler"), collectively known as Respondents. The Respondents were served and on May 10, 2004, HCH and Hartze requested a hearing. Kesler requested a hearing on May 18, 2004. On May 28, 2004, Kesler filed an Answer. On June 1, 2004, HCH and Hartze filed an Answer.

On August 5, 2004, Administrative Law Judge issued his Third Procedural Order setting a hearing in this matter. The hearing is to begin on October 12, 2004 through October 20, 2004.


1 On August 24, 2004, the Commission approved an Order and Consent against

3 Both HCH and Hartze have entered into proposed consents. The Open Meeting is
4 scheduled for October 14, 2004. The parties are requesting that the hearing be continued until
5 October 18, 2004, to allow the Commissioners to review and decide upon the proposed consents.

6 The Securities Division and Respondents' counsel believe that a continuance is
7 appropriate in this matter.
