PROCEDURAL ORDER

BY THE COMMISSION:

By our Procedural Order dated October 13, 2004, the deadlines for filing testimony and the hearing in this matter were extended by approximately 30 days. The October 13, 2004 Procedural Order did not extend the date on which discovery responses and objections are accelerated.

On October 19, 2004, Qwest Corporation requested that the date for the acceleration of the discovery responses be extended from November 30, 2004 to December 31, 2004. Commission Utility Division Staff, MCI, Cox, Xspedius, DOD and AUIA do not object.

The requested extension will facilitate discovery during the holiday period and is not unreasonable.

IT IS THEREFORE ORDERED that the date for the acceleration of discovery responses established in our June 30, 2004 Procedural Order shall be extended from November 30, 2004 until December 31, 2004, so that after December 31, 2004, responses to date requests shall be made within seven days of receipt and objections shall be made within five days of receipt.

IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


