PROCEDURAL ORDER

BY THE COMMISSION:

On October 20, 2004, the Arizona Corporation Commission ("Commission") issued Decision No. 67355 in the above-captioned matter. Decision No. 67355 ordered that a Notice of Proposed Rulemaking for proposed new rules A.A.C. R14-2-2101 through -2112 as they appear in Exhibit A attached to the Decision ("Proposed Rules") be forwarded to the Arizona Secretary of State. The Proposed Rules address Customer Proprietary Network Information ("CPNI")¹ policies, including notice and verification requirements applicable to telecommunications carriers providing service within the State of Arizona.

Decision No. 67355 further ordered that public comment be scheduled regarding the Proposed Rules. Accordingly, this Procedural Order establishes a public comment hearing schedule for the Proposed Rules.

IT IS THEREFORE ORDERED that in accordance with the requirements of A.R.S. §§ 41-1022.D and 41-1023.D, a public comment hearing on the proposed new rules A.A.C. R14-2-2101 through -2112 as they appear in Exhibit A attached to Decision No. 67355 shall be held on **January 31, 2005 at 10:00 a.m.**, at the Commission's offices located at 1200 West Washington, Phoenix, Arizona 85007.

IT IS FURTHER ORDERED that the Utilities Division shall cause timely notice of the

¹ The Proposed Rules define CPNI as "information that relates to the quantity, technical configuration, type, destination, location, and amount of use of a telecommunications service subscribed to by any customer of a telecommunications carrier, and that is made available to the carrier by the customer solely by virtue of the carrier-customer relationship; and information contained in the bills pertaining to telephone exchange service or telephone toll service received by a customer of a carrier; except that such term does not include subscriber list information."

1 proposed rulemaking, including the public comment hearing date and location set forth above, to be
2 published in the Arizona Administrative Register in accordance with A.R.S. §§ 41-1022.D and 41-
3 1023.D.

4 IT IS FURTHER ORDERED that comments on the proposed new rules A.A.C. R14-2-2101
5 through -2112 will be taken into the record of this proceeding through January 31, 2005.

6 IT IS FURTHER ORDERED that in order to allow the filing of responsive written comments
7 in this docket prior to the date of the public comment hearing, companies or other interested persons
8 and entities are directed to file their initial written comments on the proposed rules in this docket on
9 or before **December 22, 2004**.

10 IT IS FURTHER ORDERED that companies or other interested persons and entities, and the
11 Commission's Utilities Division, are directed to file written comments in response to the initial
12 written comments on or before **January 19, 2005**.

13 IT IS FURTHER ORDERED that in addition to the formal public comment hearing scheduled
14 for January 31, 2005 at 10:00 a.m. at the Commission's Phoenix offices, public comment shall also
15 be taken from members of the general public on proposed new rules A.A.C. R14-2-2101 through -




