PROCEDURAL ORDER

BY THE COMMISSION:

By Procedural Order dated July 23, 2004, the Arizona Corporation Commission ("Commission") set a schedule for filing briefs and for oral argument in this matter.

By Procedural Order dated September 17, 2004, at the request of the parties, the Commission suspended the briefing schedule to allow the parties time to engage in settlement discussions. Status conferences were held on October 14, 2004 and November 18, 2004, at which time the parties reported that they continued to engage in productive settlement negotiations. Consequently, another status conference in approximately 30 days would be appropriate.

IT IS THEREFORE ORDERED that a telephonic Procedural Conference for the purpose of updating the status of settlement negotiations shall commence **January 5, 2005 at 10:00 a.m.** at the Commission's Tucson offices, 400 West Congress, Tucson, Arizona. IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113-Unauthorized Communications) continues to apply to this proceeding.

¹ This matter is being set at the same time as a status conference in the matter of the Commission Staff vs. McLeod, Docket No. T-03267A-03-0887. The matters are not consolidated, but contain similar issues. Status conferences on these two matters will be held back to back.


