
On or about December 28, 2004, Mountain Glen filed a Motion to Extend Deadlines in Decision No. 67277 which required the filing of the Developer's Certificate of Approval of Construction and the Developer's Certificate of Approval of Sanitary Facilities for Subdivisions to be filed on or before December 31, 2004 by December 28, 2004.

To date, Mountain Glen still awaits the Developer's Certificate of Approval of Construction. On December 10, 2004, ADEQ wrote to developer Jeff Vitale of Mustang Development informing him that his Application for Approval of Construction was not administratively complete and provided Mr. Vitale a two-month extension to submit a completed application in accordance with Rule 18-1-503(B). (A copy of the December 10, 2004, Notice of Administrative Deficiencies is attached hereto as Exhibit "A"). Mountain Glen will provide the commission with ADEQ's licensing decision at the time it is

1 issued. Therefore, Mountain Glen renews its Motion to Extend the deadlines to file the Developer's
2 Certificate of Approval of Construction until such time as it is issued by ADEQ.



1. No "discharge" to the "waters of the United States" pursuant to Sections 301, 309, 402, 404, and 502 of the federal Clean Water Act (CWA) are authorized by this approval. If this project results in discharge to these waters, CWA permits are necessary before commencing the discharge, pursuant to the Code of Federal Regulations Titles 33 and/or 40. Any construction in a watercourse shall comply with all terms and conditions of the Section 404 Permit program which is administered by the U.S. Army Corps of Engineers.
2. The Public Report must include, but shall not be limited to, items 2.a. thru 2.h:
 - a. The owner of an approved lot shall obtain site-specific permits for construction and operation from **Navajo County Health Department** before constructing any on-site wastewater treatment facility or Arizona Department of Environmental Quality, if xxx County is not delegated authority to approve the on-site wastewater treatment system.
 - b. If any approved lot is determined to be not suitable for construction and operation of a conventional septic disposal system, the lot owner shall obtain site-specific construction and operating permits for an alternative on-site wastewater treatment facility from **Navajo County Health Department**. The cost of an alternative on-site wastewater treatment facility may be in excess of \$15,000.
 - c. The required setback for on-site sewage systems (including the reserved disposal area) from unsubdivided land is 50 feet minimum unless the dwellings and other future improvements on the unsubdivided land will be served by a community water system, or an appropriate waiver has been obtained from the adjacent property owner(s).
 - d. The following lots may be affected by an ephemeral wash and floodplain which may restrict the space available for placement of the on-site wastewater treatment facility (including the reserved disposal area) and consequently may restrict the location and/or size of the home to be constructed on the lot:

Lots 1, 2, 3, 26, 27, 82, and 90 - 96
 - e. This approval is based upon ADEQ evaluation of sanitary facilities for a single family dwelling with or less bedrooms on each lot. Some lots may accommodate larger sewage disposal capacities, subject to local approvals.
 - f. The applicant will supply potable water initially via a hauled water arrangement; the applicant plans to provide potable water in the future via a public water system, part of which is already constructed. The applicant shall not utilize the pipes or any other part of the unapproved water system prior to applying for and receiving from the Department the following approvals:
 1. Capacity Development pursuant to 18 A.A.C. 4, Article 6;
 2. Approval of Construction pursuant to A.A.C. R18-5-507; and
 3. Approval of Sanitary Facilities for Subdivisions pursuant to 18 A.A.C. 5, Article 4.
 - g. If any of the conditions listed above are not met, the Department shall revoke the Certificate of Approval for Sanitary Facilities for Subdivision, notify the Department of Real Estate of the revocation

and take appropriate enforcement action for noncompliance with state drinking water regulations.

- h. The public subdivision report issued by the Arizona Department of Real Estate shall contain the following or similar language: "The water supply for the subdivision is being provided via hauled water rather than a regulated public water system. Water from a public water system is subject to extensive regulation to protect public health, including monitoring, treatment, and public notice requirements. Hauled water is not subject to regulatory requirements, so the water quality is not monitored or assessed by the public health agencies that regulate public water systems. If you would like additional information on steps you can take to assess the quality of your water, you may contact the Safe Drinking Water Section of the Arizona Department of Environmental Quality at (602) 771-4619."

Dear Mr. Vitale:

ADEQ review of your application referenced above is subject to the requirements of the licensing time frames statute under A.R.S. § 41-1072 through § 41-1079 and the licensing time frames rules under A.A.C. R18-1-501 through R18-1-525. During the course of review of your application, ADEQ has determined that the application is not administratively complete in accordance with the licensing time frames statute and rules and does not contain all application components required by statute or rule and necessary for ADEQ to grant the license you requested.

This letter is the written notification of this determination required under A.R.S. § 41-1074 and A.A.C. R18-1-503(C). This determination causes the running of days within all time frames on your application to suspend until you respond with all information identified on the comprehensive list of specific deficiencies attached to this letter.

Failure to submit a complete application in accordance with R18-1-503(A) within TWO MONTHS of receipt of this notice means that ADEQ expects to proceed to a final licensing decision on your application without further notice.

You may, in lieu of submitting some or all of the components identified on the list, submit whatever information you believe necessary to support the grant of the license you requested along with a timely written "notice of intent to rely on the application components as submitted" under A.A.C. R18-1-205(B) and R18-1-520. A timely notice is one submitted prior to ADEQ making a licensing decision on your application and submitted within:

TWO MONTHS, ONE MONTH, TWO WEEKS, ONE WEEK,

Upon receipt of a timely notice, ADEQ must either (1) rescind or modify its request for the application component or components objected to in your notice or (2) make a licensing decision. Also, if the running of days within the time frames is suspended, receipt of a timely notice by ADEQ will cause the running of days to resume.
