MOTION TO SUSPEND
PROCEDURAL SCHEDULE

14 Qwest Corporation hereby requests that the Administrative Law Judge ("ALJ")
15 issue an order (1) suspending the procedural schedule currently set in this matter; (2)
16 ordering that a new procedural conference for the purposes of setting a hearing will be
17 scheduled within five business days of receipt of notice that a settlement has been
18 reached by the parties to this docket or that the parties are unable to reach a settlement;
19 and (3) ordering that a hearing commence in this matter as soon after the procedural
20 conference as the matter may be practicably heard.

21 This matter is set to begin hearing on February 10, 2005. Qwest has today filed a
22 letter, a copy of which is attached hereto as Exhibit A, requesting that Staff convene a
23 series of meetings for the purpose of discussion among the parties of settlement of this
24 docket. It would be an unnecessary waste of the resources of the parties and the
25 Commission to have the hearing proceed while settlement negotiations are ongoing. It
26 will not prejudice any party to suspend the procedural schedule in this matter while

1 settlement negotiations are conducted.




