PROCEDURAL ORDER

BY THE COMMISSION:

On January 31, 2005, the Arizona Corporation Commission ("Commission") issued an Emergency Order for Provision of Electric Service ("Emergency Order") (Decision No. 67535) in the above-captioned dockets. In the Emergency Order, the Commission directed UNS Electric, Inc. ("UNS") to immediately provision electric service to Central Trucking Inc. ("CTI"), on an interim basis, until the issues raised in these dockets have been resolved. Decision No. 67535 made clear that the provision of interim service by UNS would not prejudice any claims or arguments that either UNS or Mohave Electric Cooperative, Inc. may have in the pending cases.

IT IS THEREFORE ORDERED that a Procedural Conference shall be conducted on February 16, 2005, at 1:30 p.m., at the offices of the Commission, 1200 West Washington, Phoenix, Arizona 85007. The Procedural Conference will include discussions of procedural issues, including scheduling of discovery, testimony, hearing dates, and legal briefs.


