PROCEDURAL ORDER

BY THE COMMISSION:

By Procedural Order dated January 6, 2004, the Arizona Corporation Commission ("Commission") set a procedural conference for February 7, 2005 for the purpose of monitoring the progress of settlement negotiations in this matter. At that procedural conference the parties represented that they had reached an agreement in principal to settle this matter. They requested another status conference in approximately 30 days to give them time to reduce their agreement to writing and file it in the docket.

IT IS THEREFORE ORDERED that a telephonic Procedural Conference for the purpose of updating the status of settlement negotiations shall commence **March 7, 2005 at 10:00 a.m.** at the Commission's Tucson offices, 400 West Congress, Tucson, Arizona. 
