

On January 19, 2005, Intermedia Communications, Inc. ("Company") filed an application ("Application") with the Arizona Corporation Commission ("Commission") to cancel the Company's Certificates of Convenience and Necessity. Intervention shall be permitted to any person entitled by law to intervene and who has a direct and substantial interest in this matter. The granting of motions to intervene shall be governed by A.A.C. R14-3-105. The granting of intervention, among other things, entitles a party to present sworn evidence at a hearing and to cross-examine other witnesses. If no objection to the Application is made, the Commission may grant the Application without a hearing.
