

**MOTION TO CONSOLIDATE**

Coronado Utilities, Inc. ("Coronado") hereby files this Motion to Consolidate the above-captioned matter with Docket No. SW-04305A-05-0087, in the interests of administrative efficiency. Coronado has filed an application for a new Certificate of Convenience and Necessity ("CC&N"). Pursuant to A.A.C. R14-2-602(A)(g), Coronado is also required to provide information on how the wastewater infrastructure will be financed as part of the CC&N application. This information will be addressed, in detail, in Coronado's financing application, filed concurrently with its CC&N application. Therefore, the two matters are inextricably linked and consolidation of the two applications is consistent with the interests of administrative efficiency.


