

**Telephone:** Qwest Communications, (800) 244-1111. Completion date to individual lot lines: January 30, 2005. Purchasers' costs as advised by the subdivider: "\$27.50 connection fee; possible deposit required, pending a credit check".

**Natural Gas:** UniSource Energy Services, (928) 774-4591. Completion date to individual lot lines: January 30, 2005. Purchasers' costs as advised by the subdivider: "\$25.00 connection fee and \$85.00 deposit".

**Water:** Utility Source, LLC (Bellemont Water System PWS No. 03-300), (480) 892-8756. Completion date to individual lot lines: January 30, 2005. Purchasers' costs as advised by the subdivider: "\$19.00 service fee and a \$25.00 deposit".

The Arizona Department of Water Resources in its letters dated March 22, 2004 and August 16, 2004 cite in part: "The water supply for this development has been determined to be inadequate by the Arizona Department of Water Resources per A.A.C. R12-15-703 (B)(c)."

**NOTE: THE ARIZONA CORPORATION COMMISSION (ACC) HAS NOT APPROVED UTILITY SOURCE, LLC, AS A PUBLIC WATER COMPANY BECAUSE IT HAS NOT BEEN ISSUED A CERTIFICATE OF CONVENIENCE AND NECESSITY (CC&N). THE CURRENT STATUS FOR WATER SUPPLY IS STATED AS "INADEQUATE WATER". CURRENTLY UTILITY SOURCE, LLC IS IMPROVING THEIR FACILITIES AND IS SCHEDULED TO BE REVIEWED BY THE ACC IN NOVEMBER 2004.**

**AT THIS TIME, THE ACC HAS ORDERED UTILITY SOURCE, LLC TO CONTINUE TO PROVIDE WATER SERVICE TO EVERY HOME THAT ALREADY HAS A WATER METER INSTALLED. UTILITY SOURCE, LLC HAS BEEN ORDERED TO NOT INSTALL ANY MORE WATER METERS.**

**IN ITS LETTER DATED SEPTEMBER 15, 2004, THE ACC HAS ALLOWED UTILITY SOURCE, LLC TO PROVIDE WATER SERVICE TO LOTS 13-48, PENDING THE ISSUANCE OF THE CC&N.**

**RATES CURRENTLY CHARGED ARE NOT AUTHORIZED BY THE ACC AND MAY HAVE TO BE SUBSTANTIALLY INCREASED.**

### STREETS, ROADS AND DRAINAGE

**Access to the Subdivision:** The subdivider advises that the completed streets to the subdivision are public, asphalt paved streets. Coconino County currently maintains said streets with costs to purchasers for maintenance included in property taxes.

**Access within the Subdivision:** The subdivider advises that the interior streets will be private asphalt paved streets. The estimated completion date for said streets is April 30, 2005. The Homeowner's Association will maintain said streets with costs paid by lot purchaser through Homeowners Association dues and assessments.

**Flood and Drainage:** The subdivider advises that a Retention basin and drainage facilities will be installed by subdivider. The estimated completion date for said facilities is May 30, 2005. Facilities will be maintained by Homeowner's Association with costs paid by lot purchaser through Homeowner's Association dues and assessments.

### COMMON, COMMUNITY AND RECREATIONAL FACILITIES

**Within the Subdivision:** The subdivider advises that a park area, common landscaping, entry monument, private streets will be included in the subdivision, installed by the subdivider. The estimated completion date for said facilities is May 30, 2005.
