PROCEDURAL ORDER

BY THE COMMISSION:

On November 15, 2004, UNS Electric, Inc. ("UNS") filed with the Arizona Corporation Commission ("Commission") an application seeking to have territory that was previously within the certificated service territory of Citizens Utilities Company revert to UNS. Mohave Electric Cooperative, Inc. currently holds the Certificate of Convenience and Necessity for the territory that is in dispute.

On December 6, 2004, UNS filed a Supplement to its Application.

On December 14, 2004, the Commission's Utilities Division Staff ("Staff") filed an Amended Legal Description of the service territory that is in dispute.

On December 30, 2004, Central Trucking, Inc. filed a letter requesting intervention and seeking expedited consideration of the issues raised in the Application.

IT IS THEREFORE ORDERED that a Procedural Conference shall be conducted on January 12, 2005, at 1:30 p.m., at the offices of the Commission, 1200 West Washington, Phoenix, Arizona 85007. The Procedural Conference will include discussions of procedural issues, including scheduling of testimony and hearing dates, as well as whether settlement of the issues raised in the Application may be able to be resolved through mediation with Staff's assistance.


