BY THE COMMISSION:

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

1. Arizona Water Company ("Arizona Water" or "Company") is an Arizona corporation engaged in the business of providing water utility service to the public in portions of Arizona pursuant to authority granted by the Commission.

2. On November 18, 2004, Arizona Water filed for Commission approval of Tariff No. TS-275, Temporary Service.

3. On November 23, 2004, Staff requested Arizona Water to waive the thirty (30) day "time clock" period contained in A.R.S. 40-367.C to allow staff additional time to review the filing.



ORDER


IT IS THEREFORE ORDERED that the filing of Arizona Water Company for a Temporary Service Tariff, No. TS-275 is hereby granted.


IT IS FURTHER ORDERED that this Decision shall become effective immediately.
