BY THE COMMISSION:

On July 23, 2004, Arizona Electric Power Cooperative, Inc. ("AEPCO") and Southwest Transmission Cooperative, Inc. ("SWTC") (collectively "Applicants") filed Applications for Rate Increases. The matters were consolidated by Procedural Order dated September 15, 2004.

On January 13, 2005, Sulphur Springs Valley Electric Cooperative, Inc. ("SSVEC"), a member cooperative that purchases all of its electrical requirements from AEPCO and has it transmitted by SWTC, filed for leave to intervene in these matters.

No party objected to the intervention request.


