**PUBLIC NOTICE OF THE HEARING FOR WOODRUFF WATER COMPANY AND WOODRUFF UTILITY COMPANY FOR A CERTIFICATE OF CONVENIENCE AND NECESSITY (DOCKET NOS. W-0454A-04-0438 AND SW-0426SA-04-0439 AND W-01445A-04-0755)**

On June 10, 2004, Woodruff Water Company ("WWC") and Woodruff Utility Company ("WUC") each filed an application for a Certificate of Convenience and Necessity to provide public water and wastewater utility service, respectively, to various parts of Pinal County, Arizona. On October 19, 2004, Arizona Water Company ("AWC") filed an application to extend its Certificate(s) to include the area in which WWC is seeking a Certificate to provide water service, and also for additional areas in Pinal County, Arizona. The applications are available for inspection during regular business hours at the Commission's offices at 1200 West Washington Street, Phoenix, Arizona 85007; the offices of Woodruff Utility Company, Inc., 2555 East Camelback Road, Suite 700, Phoenix, Arizona 85016; and at the offices of Arizona Water Company, 3805 North Black Canyon Highway, Phoenix, Arizona 85015. The Commission will hold a hearing in this matter commencing on April 20, 2005, at 9:30 a.m. at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona. Public comments will be taken on the first day of the hearing. Public comments will be taken on the first day of the hearing. The law provides for an open public hearing at which, under appropriate circumstances, interested parties may intervene. Intervention shall be permitted to any person entitled by law to intervene and having a direct and substantial interest in this matter. Persons desiring to intervene must file a written notice to intervene with the Commission, which motion should be sent to the Applicants or their counsel and to all parties of record, and which, at a minimum, shall contain the following:  
1. The name, addresses and telephone number of the proposed intervenor and of any party upon whom service of documents is to be made if different than the intervenor.  
2. A short statement of the proposed intervenor's interest in the proceeding (e.g., a customer of the Applicant, a shareholder or member of the Applicant, etc.)  
3. A statement certifying that a copy of the motion to intervene has been mailed to the Company or its counsel and to all parties of record in the case.  
The granting of motions to intervene shall be governed by A.A.C. R14-3-105, except that all motions to intervene must be filed on or before March 10, 2005. The granting of intervention, among other things, entitles a party to present sworn evidence at hearing and to cross-examine other witnesses. However, failure to intervene will not preclude any customer from appearing at the hearing and making a statement on such customer's own behalf. If you have any questions or concerns about this Application or have any objections to its approval, or wish to make a statement in support of it, you may write the Consumer Services Section of the Commission at 1200 West Washington Street, Phoenix, Arizona 85007 or call 1-800-222-7000 or appear at the hearing and make comment. The Commission does not discriminate on the basis of disability in admission to its public meetings. 


