3 proposed rate increase shall commence on February 21, 2001 at 10:00 a.m. at the Arizona
4 Corporation Commission, 1200 West Washington Street, Phoenix, Arizona 85007 and that public
5 comment will be taken at the commencement of the hearing. This notice shall be reasonably posted
6 in places visible to Rio Verde's customers so that they may be noticed of the change in the hearing
7 date.


