**STAFF'S RESPONSE TO  
COMPANY REQUESTS TO  
RE-OPEN DOCKET**

On June 26, 2000, Rancho Cabrillo Water Company ("Company") filed an application for a new sewer Certificate of Convenience and Necessity. On October 16, 2000, the Company was notified that the area was already certificated, and the Company filed a request to withdraw the application. As a result, the docket was closed. Subsequently, the Company has learned that the area is not certificated. On November 28, 2000, the Company filed a request to re-open the docket and also requested that the time clock be resumed with an extension that equals the number of days between when the docket was closed and when it is re-opened. Although Staff would not be opposed to the re-filing of the application, due process requires adequate time frames be in place to allow for proper notice to interested parties as well as the opportunity for intervention. As a result, Staff would not support a recommendation that the time clock be adjusted as proposed by the Company.


