Rancho Cabrillo Water Company was granted a water certificate of convenience and necessity ("CC&N") on April 24, 2001. Conditions of the CC&N included filing with the commission a copy of the developer's certificate of assured water supply ("CAWS") and an approval to construct ("ATC") by April 24, 2002.

The developer is currently working on its zoning and its water supply issues, and estimates it will need two years to obtain the CAWS and the ATC. As a result, Rancho Cabrillo Water Company requests an extension of time until April 24, 2004 to submit the required CAWS and ATC.
