PROCEDURAL ORDER

BY THE COMMISSION:

On April 24, 2001, the Arizona Corporation Commission ("Commission") issued Decision No. 53592, which granted Rancho Cabrillo Water Company ("RCWC") a Certificate of Convenience and Necessity, subject to some conditions.

On November 1, 2001, RCWC filed a request for an extension of time to file a copy of the developer's Certificate of Assured Water Supply ("CAWS") and an approval to construct until April 24, 2004. RCWC indicated that it is working on obtaining its zoning and water supply issues, and estimated it will need two years to obtain the CAWS and approval to construct.

On November 20, 2001, the Commission's Utilities' Division Staff ("Staff") filed a memorandum stating it has no objection to RCWC's request.

Under the circumstances, Applicant's request is reasonable and should be granted.

IT IS THEREFORE ORDERED that Rancho Cabrillo Water Company's request for an extension to file a copy of the developer's Certificate of Assured Water Supply and an approval to construct is hereby granted until April 24, 2004.


