BY THE COMMISSION:

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

1. Prism Arizona Operations, LLC ("Prism" or "Applicant") has a Certificate of Convenience and Necessity ("Certificate") to provide competitive facilities-based and resold local exchange and interexchange telecommunications services in the State of Arizona pursuant to Decision No. 62725 (June 30, 2000).

2. On January 5, 2001, Prism filed with Docket Control of the Commission an application requesting cancellation of the Certificate.

3. Pursuant to Commission rules, the Commission may grant the application without a hearing.

4. On January 19, 2001, the Commission's Utilities Division Staff ("Staff") filed a Staff Report recommending approval of Prism's application for cancellation of its Certificate of Convenience and Necessity without a hearing.

CONCLUSIONS OF LAW

1. Applicant is a public service corporation within the meaning of Article XV of the

1 Arizona Constitution and A.R.S. §§ 40-281 and 40-282.

2 2. The Commission has jurisdiction over Applicant and the subject matter of the
3 application.

4 3. The cancellation of Applicant's Certificate is in the public interest.

5 4. Staff's recommendation in Findings of Fact No. 4 is reasonable and should be
6 adopted.

7 **ORDER**

8 IT IS THEREFORE ORDERED that the application of Prism Arizona Operations, LLC for
9 the cancellation of the Certificate of Convenience and Necessity to provide competitive facilities-
10 based and resold local exchange and interexchange telecommunications services shall be, and the
11 same is hereby approved.

12 IT IS FURTHER ORDERED that this Decision shall become effective immediately.
