PROCEDURAL ORDER

9 **BY THE COMMISSION:**

10 On October 10, 2000, JirehCom, Inc. d/b/a JirehCom Long Distance, Inc. ("Applicant" or
11 "JirehCom") filed with Docket Control of the Arizona Corporation Commission ("Commission") an
12 application for a Certificate of Convenience and Necessity ("Certificate") to provide competitive
13 resold interexchange telecommunications services within the State of Arizona.

14 On December 21, 2000, JirehCom filed Affidavits of Publication indicating compliance with
15 the Commission's notice requirements.

16 On January 3, 2001, the Commission's Utilities Division Staff ("Staff") filed its Staff Report
17 in this matter.

18 Pursuant to A.R.S. § 40-282, the Commission may act on an application for a Certificate to
19 provide resold telecommunications services without a hearing, or with a hearing if one is requested
20 by any party.

21 The time frame for processing this application expired on July 7, 2001.

22 Pursuant to Commission rules, the Commission now issues this Procedural Order to govern
23 the preparation and conduct of this proceeding.

24 IT IS THEREFORE ORDERED that JirehCom shall file written exceptions, if any, to the
25 Staff Report or a request that a hearing be set by **12 noon** on March 16, 2001.

26 IT IS FURTHER ORDERED that intervention shall be in accordance with A.A.C. R14-3-105,
27 except that all motions to intervene must be filed on or before **12 noon** on February 2, 2001.

28 IT IS FURTHER ORDERED that the time periods specified herein shall not be extended

1 pursuant to Rule 6(a) or (e) of the Arizona Rules of Civil Procedure.

2 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend or waive
3 any portion of this Procedural Order by subsequent Procedural Order or by ruling at hearing.
