PROCEDURAL ORDER

BY THE COMMISSION:

On November 18, 2004, the City of Chandler, Arizona ("City") filed with the Arizona Corporation Commission ("Commission") a request for approval for the Union Pacific Railroad ("Railroad") to upgrade an existing crossing at Pecos Road in the City, Maricopa County, Arizona at AAR/DOT 741-674-P.

IT IS THEREFORE ORDERED that the request of the City of Chandler shall be considered an application for the Railroad to upgrade an existing public railroad crossing pursuant to A.R.S. § 40-337, et seq.

IT IS FURTHER ORDERED that the Railroad shall be considered as the Respondent in this proceeding.

IT IS FURTHER ORDERED that the hearing on the application shall be held on January 6, 2005 at 2:00 p.m., or as soon thereafter as is practical, at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.




