**Grounds for Complaint:** On November 2, 2004 the Commission issued its order in the Arbitration between Autotel and Qwest Corporation. On December 1, 2004, Autotel informed Qwest that the interconnection agreement Qwest had prepared did not comply with the Commission Order because Qwest inserted a new section IV.C.3.d. in the

agreement. Autotel is unable to find anywhere in the Commission Order where the IV.C.3.d. terms and conditions were ordered by the Commission. Qwest has refused to modify the interconnection agreement to comply with the Commission Order.

**Request for Relief:** Autotel requests the Commission order Qwest to prepare three new interconnection agreements with the IV.C.3.d. section removed.


