



22 On November 29, 2004 there came on for hearing before the Court the Joint Motion for
23 Expedited Approval of a Settlement and Compromise of Claims Including, As A Material Part, a Sale of
24 Estate Assets and for Related Relief. The Motion was noticed as set forth in the Certificate of Service and
25 the Certificate of Publication filed with the Clerk of Court. After a call for higher and better bids no offers
26 whatsoever were made for the property being sold. One (1) objection was filed to the Motion. The Court
27 having considered the file, the evidence presented and the argument of counsel, it is hereby

28 **ORDERED, ADJUDGED AND DECREED** that the Joint Motion is approved with the
29 Chapter 7 Trustee, Ronald L. Ancell, being authorized to take all action necessary to consummate the
30 settlement, compromise and sale described in the Joint Motion. The findings of fact and conclusions of law
31 announced at the November 29, 2004 hearing are incorporated herein by this reference. The Court does
32 not find any collusion in the terms of sale or that the Purchasers did not act and purchase in good faith.
