PROCEDURAL ORDER

BY THE COMMISSION:

On June 18, 2004, Pineview Water Company ("Pineview" or "Applicant") filed an application with the Arizona Corporation Commission ("Commission") for authority to issue promissory note(s) and other evidences of indebtedness payable at periods of more than twelve months after the date of issuance not to exceed \$730,978.

On July 9, 2004, Pineview filed a rate application with the Commission.

By Procedural Order issued October 5, 2005, a hearing on the application was scheduled for February 24, 2005.

On December 8, 2004, the Commission's Utilities Division Staff ("Staff") filed a Motion to Consolidate ("Motion"), stating that the financial situation of Pineview will be under review in both dockets, and that the prudence of the financing may be affected by the level of rates approved in the rate docket. The Motion stated that Pineview does not oppose the consolidation.

On December 17, 2004, a copy of the Motion was provided to the intervenors in the rate case with instructions to respond to the Motion by January 7, 2005.

No opposition to the Motion was filed.


