**STAFF'S NOTICE OF FILING
LATE-FILED EXHIBITS**

Beaver Dam filed applications for an extension of its existing CC&N, for approval of long-term financing, and for approval of the sale of assets and transfer of the CC&N of Littlefield Water Company ("Littlefield") to Beaver Dam Water Company ("Beaver Dam"). On December 16, 2004, a hearing was held on all 3 applications. At the hearing, the Administrative Law Judge ("ALJ") ordered Utilities' Division Staff ("Staff") of the Arizona Corporation Commission ("Commission") to file a late-filed exhibit that attaches the notice of publication and the legal descriptions for where Beaver Dam wants to extend their area. Staff has attached two notices of publication (dated August 24, 2004 and October 23, 2004).

Staff has attached three legal descriptions with maps (dated July 27, 2004 and September 13, 2004) which were attached to the Staff Report filed on November 30, 2004. Staff has also attached a legal description with a map (dated April 12, 2004) that was not attached to the Staff Report. Staff

1 has attached the legal description of Littlefield from Commission Decision No. 47690. Finally, Staff
2 has attached the legal description of the area that was deleted from Littlefield's certificated area in
3 Commission Decision No. 65977.

4 At the hearing, one of the issues discussed had to do with charging Beaver Dam's large meter
5 rates in Littlefield's certificated area. Staff's position is that there is support of the proposed rates
6 from large meter customers that currently exist in Littlefield. Staff has attached a letter dated
7 December 28, 2004 from Bob Frisby at Beaver Dam Water Company. This exhibit shows that
8 Willow Springs RV Park is not a large meter customer of Littlefield and that Canyon View Mobile
9 Home Park supports the proposed rates. One of the attachments to Mr. Frisby's letter is a letter dated
10 December 23, 2004 from the owner of Canyon View Mobile Home Park that is in support of Beaver
11 Dam's proposed tariff changes. Staff would have no objection if the Administrative Law Judge
12 believes further proceedings are necessary to hear testimony on the claims by Mr. Frisby in his
13 December 28, 2004 letter.



On June 15, 2004, Beaver Dam Water Company, Inc. ("Beaver Dam") filed an application with the Arizona Corporation Commission ("Commission") for an extension of Certificate of Convenience and Necessity ("CC&N") to provide water service to an area in Mohave County, and also filed an application for approval of long-term financing. On September 9, 2004, Beaver Dam amended its CC&N extension application to include additional territory. Also on September 9, 2004, Beaver Dam and Littlefield Water Company ("Littlefield") filed a joint application with the Commission requesting approval of the sale of Littlefield's assets and transfer of Littlefield's CC&N to Beaver Dam. The above-described consolidated applications are granted, Littlefield will no longer provide service in its designated territory, but Beaver Dam would be the exclusive provider of water in Littlefield's territory as well as in the proposed extension area, and will be required to file the Commission to provide service to all the affected areas under rates and charges and terms condition established by the Commission.

Applications are available for section during regular business hours at the offices of the Commission in Phoenix, at 1200 West Washington Street, Phoenix, Arizona, and at the offices of Beaver Dam, 3333 E. Clark Gable Dr., Beaver Dam, Arizona. The recommendations of the Commission's Utilities Division on the consolidated applications will also be available at those locations after November 2004.

The Commission will hold a hearing on this matter beginning December 2004 at 1:30 p.m., at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona. Public comment will be taken on the first day of the hearing.

The law provides for an open public hearing at which, under appropriate circumstances, interested parties may intervene. Intervention shall be permitted to any person entitled by law to intervene and having a direct and substantial interest in the matter. Persons desiring to intervene must file a written motion to intervene with the Commission, which motion should be sent to the companies or their counsel and to all parties of record, and which at the minimum, shall contain the following:

- 1- The name, address, and telephone number of the proposed intervenor and of any party upon whom service of documents is to be made if different than the intervenor.
- 2- A short statement of the proposed intervenor's interest in the proceeding (e.g., a customer of the companies, a shareholder of the companies, etc.).
- 3- A statement certifying that a copy of the motion to intervene has been mailed to the companies of their counsel and to all parties of record in the case.

The granting of motions to intervene shall be governed by A.A.C. R14-3-105, except that all motions to intervene must be filed on or before November 19, 2004. The granting of intervention, among other things, entitles a party to present sworn evidence at hearing and to cross-examine other witnesses. Failure to intervene will not preclude any potential customer from appearing at the hearing and making a statement on such person's own behalf. You will not, however, receive and further notice of the proceeding unless requested by you.

After our hearing I had several Conversations with Michael Howeth ADEQ Section Manager Flagstaff regarding Littlefield Water system's well and current deficiencies (enclosed find a memo from John Calkins ADEQ to Michel Howeth). We will do the delinquent monitoring and this would enable us to bring the water system #08-025 into compliance within 12 months. We would like to keep this well as a backup to our existing systems.


There were two projects Canyon View Mobile Home Park and Willow Springs RV Park with large meters that Michael Hart owned and connected to the Littlefield Water system in 2000 without obtaining Approval to Construct ADEQ, Mohave County Environmental Health Permits or Mohave County Planning and Zoning Permits. Mr. Hart was to make extensive improvements to the system that were never completed nor was permission ever given by Littlefield Water to connect the projects (enclosed letter Littlefield Water/Melvin Peterson). Willow Springs RV Park / Mr. Hart has not paid Littlefield Water for any water service since they closed in 2002.

Canyon View Mobile Home Park has been owned by David Fenn and James Robbins since 2002. Enclosed is a copy wherein they agree with the proposed tariff rates. It should be pointed out the Finn Robbins group is contributing \$135,360 of their portion of the \$410,998 line extension to connect the systems. They have also been working with ADEQ Northern Regional office to bring this project into compliance.

Willow Springs RV Park is still owned by Michael Hart. This project still has a Cease and Desist Order in effect from Mohave County Environmental Health (enclosed). We have contacted Mr. Hart has said that he can not pay any portion of the Project costs. Willow Springs RV Park has had a closed sign on it for the last 2 years and is not a customer of Littlefield Water.

We believe that the Canyon View Mobile Home Park is the only existing customer at this time.


Mr. Hart did not have permission from Littlefield Water to connect his projects until all permits and improvements were completed.




