PROCEDURAL ORDER

BY THE COMMISSION:

On February 3, 2005, Qwest Corporation filed with the Arizona Corporation Commission ("Commission") an Emergency Motion to Suspend the Inflation Minus Productivity Factor Adjustment in its Price Cap Plan approved in Decision No. 63487. In Decision No. 66772 (February 10, 2004) the Commission declined to interpret the Price Cap Plan as limiting the number of annual adjustments and ordered Qwest to make a productivity adjustment for Basket 1 services on April 1, 2004 and annually thereafter.

On February 8, 2005, the Residential Utility Consumer Office filed a Response to Qwest's Motion.

IT IS THEREFORE ORDERED that a procedural conference for the purpose of hearing oral argument on the Motion shall commence on **March 3, 2005**, at 10:30 a.m.¹, or as soon thereafter as is practicable, at the Commission's offices, 1200 West Washington, Phoenix, Arizona. 
IT IS FURTHER ORDERED that if not already filed, parties shall file any Responses to the Motion no later than **February 23, 2005**.


