6 **MOTION FOR CONTINUANCE**

7 By an Arizona Corporation Commission (“Commission”) Procedural Order entered in this
8 matter on October 31, 2000, Verizon Select Services Inc. (“Verizon Select”), fka GTE
9 Communications Corporation, was ordered to file its proposed witnesses and the subject matter of
10 their testimony by January 5, 2001, with a hearing on the consolidated applications thereafter
11 scheduled for January 8, 2001. Verizon Select, through its counsel undersigned, hereby requests
12 that these two dates be continued for approximately two weeks.

13 Since the finalization of the merger of GTE Corp. (Verizon Select’s parent company) and
14 Bell Atlantic Corporation, there have been considerable reassignments of individuals responsible
15 for or familiar with the original applications in this proceeding. Moreover, the injection into the
16 proceeding of the “fair value” issue by the Commission’s prior Procedural Order of September
17 27, 2000, has affected Verizon Select’s choice of witness in this matter. Combined with the
18 Christmas and New Year’s holidays, this has delayed final witness selection and hearing
19 preparation, thus necessitating this short delay.

20 Verizon Select has contacted counsel for Commission Staff and intervenor Qwest
21 Communications, and they have authorized Verizon Select to represent that they do not oppose
22 the requested continuance. Moreover, Verizon Select will agree to a corresponding two week
23 extension of the deadline for processing its most recent application under A.A.C. R14-2-510 (E).
