MOTION TO EXTEND TIME FOR FILING  
COMMENTS TO STAFF REPORT  
(Expedited Consideration Requested)

Arizona Water Company (the "Company") moves the Commission to enter an order extending the time for parties to file comments to the Staff Report in the above-referenced consolidated docket.

The Company received its copy of the Staff Report on March 7, 2005. The Staff Report is approximately seventy-seven (77) pages long, and addresses, among

1 other things, the Company's and Woodruff Water Company's applications to expand  
2 and obtain, respectively, certificated area, wastewater treatment and reuse issues, and  
3 Staff's criteria on which its recommendations are based.

4 A Procedural Order entered on January 24, 2005 provides that comments to the  
5 Staff Report must be filed no later than March 13, 2005 (as this day is a Sunday, the  
6 actual filing deadline would be March 14). The Company submits that, due to the length  
7 and complexity of the Staff Report, the number of issues it addresses, and the  
8 importance and complexity of this case, it is reasonable to allow the parties additional  
9 time to file comments to the Staff Report. In addition, as the hearing in this matter will  
10 not take place until April 20, 2005 -- more than a month after the current deadline for  
11 comments -- no party to this matter will be prejudiced by permitting additional time to  
12 comment.

14 The Company has contacted counsel for Staff and Woodruff (via voice mail)  
15 concerning this Motion. Staff has indicated that it cannot yet say what its response to  
16 the Motion will be. Woodruff has not yet responded.

18 For the foregoing reasons, the Company respectfully requests that the  
19 Commission enter an order extending the time for filing comments to the Staff Report to  
20 March 28, 2005. In view of the March 14, 2005 deadline, the Company also requests  
21 that the Motion be acted upon no later than March 10, 2005.
