PROCEDURAL ORDER

BY THE COMMISSION:

7 On November 22, and December 13, 2002, Arizona-American Water Company, Inc.
8 (“Arizona-American” or “Applicant”) filed with the Arizona Corporation Commission
9 (“Commission”) applications in the above-captioned dockets for rate increases in the Applicant’s
10 water and wastewater districts.
11

12 On January 30, 2003, the Commission’s Utilities Division Staff (“Staff”) filed a letter stating
13 that the applications met the sufficiency requirements set forth in A.A.C. R14-2-103.

14 On February 19, 2003, a procedural conference was conducted in this proceeding to discuss
15 consolidation of the dockets and to discuss other procedural matters.

16 On March 14, 2003, a Procedural Order was issued setting the dates and times for hearing.

17 On June 6, 2003, a Procedural Order was issued setting revised dates for the filing of
18 testimony and the hearing.
19

20 On June 12, 2003, Staff filed a Motion to Amend the Procedural Order issued June 6, 2003,
21 requesting that revised dates be set for objections to testimony and exhibits, and for final discovery
22 requests. Staff represented that no other party opposed the request. By Procedural Order issued June
23 16, 2003, Staff’s Motion was granted, and it was ordered that any objections to testimony or exhibits
24 that have been prefiled as of November 14, 2003, shall be made by November 26, 2003; no discovery
25 requests shall be served after November 24, 2003; and that in all other respects, the March 14, 2003
26 Procedural Order, as modified by the June 6, 2003 Procedural Order, will remain in full force and
27 effect.

1 The Commission has scheduled a number of public comment hearings in the service areas
2 affected by the application.

3 IT IS THEREFORE ORDERED that public comments on the above-captioned consolidated
4 matters will be held in the following cities:


