During the April 14, 2005 hearing on these matters, AEPCO and SWTC witnesses testified as to the expected retail end-user impacts of the total 3% in deferred rate increases in 2006 and 2007. The testimony given at hearing estimated an average residential bill increase of about 10 cents per month in relation to the AEPCO deferred request and an average monthly increase of about 2 cents attributable to the SWTC deferred request.

After the hearing concluded, the witnesses realized that these calculations had misplaced the decimal point and were erroneous. Instead, the correct estimated average residential monthly bill increase of the 3% deferred rate increases would be about 90 cents in relation to the AEPCO request and would be approximately 22 cents in relation to the SWTC request. We apologize for the error.


