PROCEDURAL ORDER

BY THE COMMISSION:

On October 5, 2004, Arizona Water Company ("AWC") filed an Application for an Extension of its Certificate of Convenience and Necessity ("CCN" or "Certificate") for its Oracle system in Pinal County with the Arizona Corporation Commission ("Commission").

On November 12, 2004, Commission Utilities Division Staff ("Staff") notified AWC that the application was insufficient pursuant to the requirements of the Arizona Administrative Code.

On April 20, 2005, Staff docketed a letter that notified AWC that the application was deemed sufficient.

Accordingly, pursuant to A.A.C. R14-3-101, the Commission now issues this Procedural Order to govern the preparation and conduct of this proceeding.

IT IS THEREFORE ORDERED the hearing in the above-captioned matter shall be held on **July 7, 2005, at 10:00 a.m.** or as soon thereafter as is practical, at the Commission's offices, **Room 131**, 400 West Congress St., Tucson, Arizona 85701.

IT IS FURTHER ORDERED that intervention shall be in accordance with A.A.C. R14-3-105, except that all motions to intervene must be filed on or before **June 24, 2005**.

IT IS FURTHER ORDERED that Applicant shall serve public notice of the hearing in this matter, in the following form and style:

1 public meetings. Persons with a disability may request a reasonable accommodation
2 such as a sign language interpreter, as well as request this document in an alternative
3 format, by contacting Linda Hogan, ADA Coordinator, voice phone number 602/542-
3931, E-mail LHogan@cc.state.az.us. Requests should be made as early as possible
4 to allow time to arrange the accommodation.

5 IT IS FURTHER ORDERED that AWC shall publish the above notice in a newspaper of
6 general circulation within the proposed extended service territory and shall mail to each property
7 owner in the requested service territory a copy of this notice by first-class U.S. Mail, to begin as soon
8 as possible and to be completed on or before **June 15, 2005**.

9 IT IS FURTHER ORDERED that AWC shall file certifications of mailing and publication as
10 soon as practicable after the mailing has been completed.

11 IT IS FURTHER ORDERED that notice shall be deemed complete upon mailing,
12 notwithstanding the failure of an individual customer to read or receive the notice.

13 IT IS FURTHER ORDERED that Staff shall file its Staff Report and associated exhibits to be
14 presented at the hearing on or before **June 15, 2005**.


15 IT IS FURTHER ORDERED that any objection or response by the Applicant to the Staff
16 Report shall be made in writing and filed on or before **June 30, 2005**.

17 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113-Unauthorized
18 Communications) applies to this proceeding as the matter is now set for public hearing.

19 IT IS FURTHER ORDERED that the time periods specified herein shall not be extended
20 pursuant to Rule 6(a) or (e) of the Rules of Civil Procedure.

21 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
22 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
