Dear Judge Rodda:

Qwest Corporation ("Qwest") hereby notifies you that by copy of this letter it is offering to delete subsection IV.C.3.d of the Wireless Interconnection Agreement – Arizona Between Qwest Corporation and Autotel ("Agreement") and to insert the sentence "Reciprocal Compensation does not apply to Transit Traffic" as the last sentence in section IV.F of the Agreement if that will resolve Autotel's formal complaint and conclude this arbitration. Qwest is making this offer out of consideration for your time and that of the Commission because it fails to see how it makes any difference where this agreed language appears in the Agreement.

If Autotel will accept this offer in writing, acknowledging that the Agreement to be submitted by Qwest complies with the Commission's order, Qwest will submit a new Agreement to Autotel for signature. The new Agreement will be identical to the prior Agreement submitted by Qwest to Autotel except for the change set forth in the foregoing paragraph.


In the meantime, Your Honor may wish to defer ruling on the issue.
