**APPLICATION OF XO COMMUNICATIONS
 FOR LEAVE TO INTEREVENE**

XO Communications Services, Inc. ("XO"), pursuant to A.A.C. Rule 14-3-105 of the Arizona Corporation Commission Rules of Practice and Procedure, hereby applies to intervene in the above-captioned proceeding and states the following:

- XO is a telecommunications corporation certified to provide local exchange, intraexchange, and interexchange telecommunications services throughout the state of Arizona.

2. XO currently competes with Qwest Corporation ("Qwest) in the provision of telecommunications services. Qwest has filed a Renewed Price Regulation plan that seeks greater flexibility for Qwest with respect to pricing and product services.

3. XO is directly and substantially affected by the above-captioned proceedings. XO has, since Qwest's initial case filing in 2003, used the Arizona Corporation Commission's public file to monitor the case and evaluated closely the issues raised by Qwest and the scope of the docket. As a result of recent settlement negotiations by the parties, substantive information regarding the nature of the disputes being resolved is no longer available in the public docket. While XO does not intend to raise new issues in the docket, it does have an interest in knowing what issues are being addressed and resolved.

4. XO does not seek to unduly broaden the nature or scope of the issues being discussed in the docket.


