
Ladies and Gentlemen:

Pursuant to that certain Opinion and Order, Decision No. 66843, dated as March 12, 2004 in the above-referenced matter (the "Opinion and Order"), Sunrise Well Association, Inc. (the Association") is required to file with the Arizona Corporation Commission on or before February 15<sup>th</sup> of each year, a certification signed by an officer of the Association stating that those provision of the Association's bylaws in existence as of the date of the Opinion and Order which (i) restrict further subdivision of the current fifteen parcels in the requested adjudication area, (ii) limit the number of memberships in the Association to fifteen, and (iii) grant equal voting rights to members who have active water-line connections from the members' parcels to the Association's water system, have not been altered, amended or repealed.
