**MOTION TO CONSOLIDATE**

Circle City Water Company, L.L.C. ("Circle City"), an Arizona public service corporation, hereby moves to consolidate the above-captioned matter with Docket No. W-03510A-05-0146. In this docket, Circle City seeks to establish a means to fairly allocate the costs of building off-site water utility infrastructure (water mains and transmission lines, wells, storage tanks, booster stations and the like) to those creating the need for such infrastructure. This is consistent with the Commission's policies regarding the impact of growth on current water utility customers.

In Docket No. W-03410A-05-0146, Circle City is seeking to expand its Certificate of Convenience and Necessity ("CC&N") to accommodate new growth in the vicinity of its existing service area. The preferred means of financing the off-site and backbone infrastructure needed to extend water utility service to persons within this proposed new service area is through a Commission approved Hook-Up Fee Tariff. Because the generic issues in this docket are relevant to Circle City's request to extend its CC&N, consolidation of the two applications is consistent with the interests of administrative efficiency. Therefore, Circle City asserts that granting this Motion to Consolidate will serve the public interest.


