PROCEDURAL ORDER

BY THE COMMISSION:

On December 15, 2004, Red River Networks, LLC ("Applicant" or "Red River") filed with the Commission an application for a Certificate of Convenience and Necessity ("Certificate") to provide competitive resold interexchange telecommunications services within the State of Arizona.

On February 28, 2005, the Commission's Utilities Division Staff ("Staff") filed a Staff Report in this matter recommending approval of the application subject to certain conditions including, but not limited to, the requirement that Red River obtain a performance bond in the amount of \$10,000.

On March 11, 2005, Red River filed a revision to its Arizona tariff by which it indicated that it will not require its customers to provide deposits, advances or prepayments. In accordance with this revision, Red River requested a waiver of the performance bond recommended by Staff in its February 28, 2005 Staff Report.

IT IS THEREFORE ORDERED that Staff shall file a response to Red River's March 11, 2005 filing on or before April 1, 2005, which indicates whether the waiver should be approved given Red River's tariff revision.


