**Arizona-American Water Company's
Motion To Delete Tubac Water District From Application**

Arizona-American Water Company ("Arizona-American") asks to amend its application in these dockets to delete the requested relief concerning its Tubac Water District. In response to its customers' desires, Arizona-American is evaluating another arsenic-remediation technology for the Tubac Water District and has asked the Arizona Department of Environmental Quality for a 12-month compliance delay to allow time for this evaluation. This technology could be more cost effective and may not lend itself to the ACRM procedure. Therefore, an ACRM request for the Tubac Water District is not appropriate at this time.


Counsel for Arizona-American has spoken to counsel for Commission Staff ("Staff") and counsel for the Residential Utility Consumers Office ("RUCO") concerning this motion. Each

has stated that his client has no objection to this request. Mr. Meek from the Arizona Utilities Investors Association is out of town this week.

For the convenience of the parties, Arizona-American will submit revised testimony that deletes all references to the Tubac Water District. No other portions of the testimony will change. Staff and RUCO counsels each stated that the revised testimony will require no additional time to prepare testimony, so the original 60-day schedule need not be altered.

Arizona-American reserves the right to make an ACRM filing for its Tubac Water District in a new docket at a later date.
