- 16 1. I am Ron McDonald, General Manager of Pineview Water Company. My business

18 2. I was a witness at the hearing on the matters in the subject docket.
19 3. I am of the opinion that two of the major issues in this proceeding were Wages and
20 Salaries and the Pension and Benefits provided to be Company's President, Secretary,
21 and a consultant.

- 1 4. The Company is of the opinion that the Staff has recommended removal of the Wages
2 and Salaries for the above individuals in the amount of \$47,015, and what was
3 believed to be the related Pensions and Benefits in the amount of \$7,557.

5 recommended by Staff, I failed to advise the Company's rate consultant or counsel, or


