PROCEDURAL ORDER

BY THE COMMISSION:

13 In Decision No. 66893 (April 6, 2004), the Arizona Corporation Commission
14 ("Commission") granted Arizona Water Company's ("AWC") application for an extension of its
15 Certificate of Convenience and Necessity for its Casa Grande system, subject to certain conditions.

16 Specifically, AWC was ordered to file (1) a copy of the Developer's Assured Water Supply
17 for each development with the Commission within 365 days of the Decision and (2) a main extension
18 agreement associated with the extension area within 365 days of the Decision. Pursuant to Decision
19 No. 66893, failure to meet these conditions within the specified time will render the Decision null
20 and void without further Order of the Commission.

21 On March 30, 2005, AWC filed a Request for Additional Time to Comply with the Filing
22 Requirement ("Request"). By its filing, AWC requested an additional 365 days to comply with the
23 above referenced conditions based upon the fact that development in the proposed expansion area
24 will be delayed for a year.

25 IT IS THEREFORE ORDERED that the Commission's Utilities Division Staff shall respond
26 to AWC's Request on or before April 11, 2005.


